The Parade Committee agrees that the Entrant may add an entry to the Festival of Lights Parade, as part of providing enjoyment to the people of Williams and surrounding communities by promoting the public image of the Entrant. This parade, and all the Entrants, shall move in an orderly manner from Redinger Park to Museum Park where the parade ends. This parade will begin at 7:00 pm on December 8th, 2018. Entrant is responsible for providing the Parade Committee with signed copies of the Participation Agreement and Entry Application with application fee prior to parade date. The signing of said agreement acknowledges entrant has read the criteria and parade rules/regulations set forth by The Parade Committee. The Entrant, their company or organization, and all participants, agrees to indemnify and hold harmless the Parade Committee, its volunteers, sponsors alike, of all liability, claims, actions, damages, expenses or loss due to or arising from the Entrant's participation in the parade. This agreement shall not be assigned or transferred by the Entrant. This Agreement shall be governed by the laws of the State of California.

Float Rules and Regulations Saturday, December 8th, 2018

ROUTE:

Starting at Redinger Park, West on E Street, Ending at Museum Park.

ENTRY FEES:

Entry fees must be paid with submission of the registration form. Registration will not be allowed without entry fees.

JUDGING:

Floats will be judged on workmanship, animation, crowd participation, creativity, use of lights, and music.

PARADE FLOAT CRITERIA:

1. Parade entry must be family oriented.
2. Must have 1000 or more lights.
3. NO WALKING permitted without prior approved.

RULE AND REGULATIONS:

1. No solicitations apart from a Parade Committee pre-approved charitable organization.
2. ALL children entered into parade, must be supervised by an adult.
3. All parade entries must carry a fire extinguisher.
4. No smoking on or near parade entries.
5. Alcoholic beverages or any illegal substances are forbidden.
6. NO ANIMALS are permitted in the parade without pre-approval.
7. All entrants must sign the parade agreement prior to parade commencement.
8. All entries MUST be lined up 30 minutes prior to parade start time.
